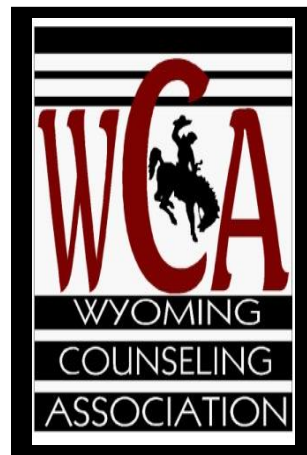
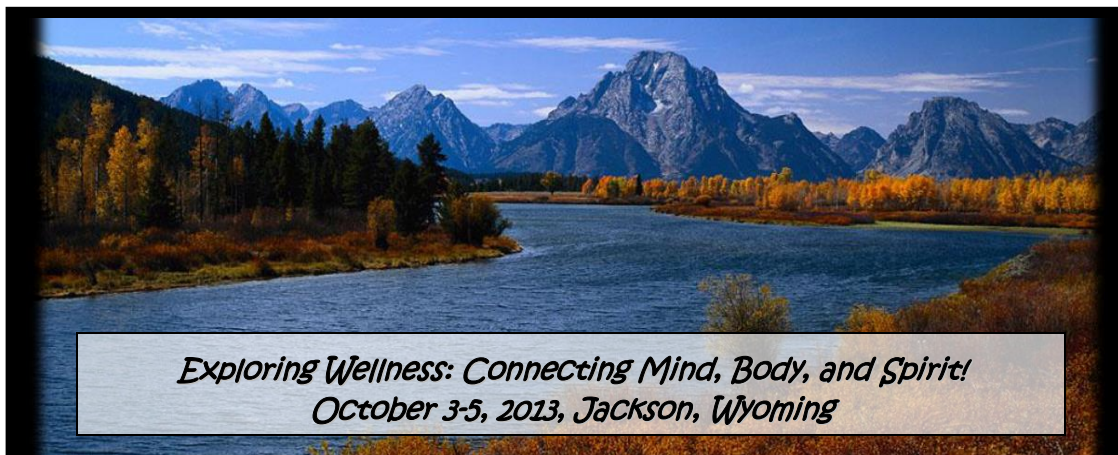


# Wyoming Counseling Association 2013 Annual Conference
